From the Energy Policy Act of 2005

On June 22, 2005, an amendment to the Energy Policy Act of 2005 was passed in U.S. Senate and includes the following: "Congress finds that—

- "(1) greenhouse gases accumulating in the atmosphere are causing average temperatures to rise at a rate outside the range of natural variability and are posing a substantial risk of rising sea-levels, altered patterns of atmospheric and oceanic circulation, and increased frequency and severity of floods and droughts;
- "(2) there is a growing scientific consensus that human activity is a substantial cause of greenhouse gas accumulation in the atmosphere; and
- "(3) mandatory steps will be required to slow or stop the growth of greenhouse gas emissions into the atmosphere."

On February 2, 2006 Senators Pete V. Domenici (Chair) and Jeff Bingaman (Ranking member) of the Energy Committee published a white paper on "Design Elements of a Mandatory Market-Based Greenhouse Gas Regulatory System" which you can obtain at http://energy.senate.gov/public/ total

Delmarva customers face 59% jump in bills

The following is from Steven Church's article from Delaware's February 3, 2006 News Journal:

"Electric bills for most Delaware residents will soar by 59 percent May 1 when price caps end and consumers are exposed to the full impact of an unregulated power market, the state's main electric company said Thursday. Delmarva Power, which supplies more than 80 percent of Delaware electricity customers, will boost rates in May to pay for dramatic increases in the cost of the fuels used to generate power, the company said Thursday. The hike will bring the typical customer's bill (based on 1,000 kilowatt hours) to \$145 a month from \$91, according to Delmarva."

What do you do with candelabra light sockets?

Candelabra sockets are small. We find them in chandeliers, pendant fixtures, wall sconces. We could buy a candelabra based, flame-shape compact fluorescent lamps, but the wattage is usually low and the light quality does not seem as good. Pamela Bracey of Calvary Church, Germantown (and Pleasantview Baptist Church) did some research to find that www.bulb.com sells an adapter for \$1.99 each that modifies a candelabra socket into a standard, medium-base socket that accepts the higher wattage, better color, compact fluorescents. Their product number is \$51. Their minimum order is \$19.95 (10 sockets), and their shipping charges for that are \$7.90. Thanks Pamela!



40% Reduction in One Oil Delivery to Low Income Households

Thanks to Citizens Energy and the Citgo Oil Company, a

new discount oil program for low income oil heated households, especially those who have received and exhausted their LIHEAP cash and/or crisis benefits has started February 1, 2006. Low income households get one delivery of up to 200 gallons of home heating oil from one of five specific oil dealers. The oil customer pays 60% and Citizen's Energy pays the remaining 40%, passing on an oil discount from Citgo Oil Company, authorized by the



Venezuelan government. This applies to households in Philadelphia, Delaware, Bucks, Montgomery and Chester counties that earn 150% of federal poverty level or less:

1 person = \$14,700	3 people = \$24,900	5 people = \$35,200
2 people = \$19,800	4 people = \$30,000	6 people = \$40,200

Applicants must apply for LIHEAP and Crisis first. After LIHEAP closes, applicants may apply at their local ECA Neighborhood Energy Center. Applications will be taken until April 30, 2006. Call 215-988-0952 for more information Households that have already applied for LIHEAP should just wait for their authorization letter from DPW.


